OVERVIEW

From 2021-2025 Bristol has been developing an effective place-based model for climate and nature action. By putting communities at the heart of local action, they develop leadership and agency which can shape and inform strategic climate policy and action, in an inclusive and accessible way. Our aim in Bristol has been to test a model which can be repeatable and beneficial to other places. This document introduces the Community Climate and Nature Action Model.

We are in an increasingly divisive time. Support for climate and nature action is high and widespread but for some is very conditional on the perception of the costs and benefits being fairly distributed across society. A just transition is required, which will only be achieved through sensitive and complex dialogue that ensure solutions reflect the views of local people and communities.

By just transition we mean an equitable transition, where opportunities are intentionally created to reduce rather than worsen inequalities. Where action for climate and nature doesn't expect those least responsible for carbon emissions to make the biggest sacrifices, and instead creates new opportunities to improve the quality of life for people locally and globally.

Community infrastructure exists everywhere, and community organisations are experts of their place, community and lived experience. It's essential that we harness the potential of the UK's community infrastructure to catalyse climate and nature action which involves and helps to improve the quality of life of local citizens.

Community organisations provide stable, trusted – and often the only – local infrastructure to connect, support, and include new people within communities into climate and nature conversations. It is impossible to conceive how a just transition will happen without them. Community organisations are trusted messengers who meet citizens where they are at, framing their engagement around what matters to local people and their day-to-day lives.

The Community Climate and Nature Action Model positions communities as key agents of change, recognising and valuing the expertise and specialisms community organisations and the voluntary sector has. Their lived experience and knowledge of people and place is essential and makes community organisations strategic players in the national transition to net zero.

This mobilisation of community is what is needed for transformative and systemic change that will help ensure the UK's transition has a social mandate and local legitimacy.

THE COMMUNITY CLIMATE AND NATURE ACTION MODEL

The Community Climate and Nature Action Model provides a way to build the capacity, capability and influence of communities to decarbonise, build resilience and recover nature at scale whilst working with local authorities and policy makers towards shared aims and ambitions.

Through this model, Bristol has successfully supported the strategic inclusion of diverse communities – and their needs, everyday lives and interests – in low carbon transition plans and delivery. Early signs indicate this model is effective and therefore has the potential to be nationally significant.

The model is a social innovation on climate which has a dual focus on positive social, climate and nature outcomes. Through five years of coproduction and iteration with communities, the Community Climate and Nature Action Model has developed to be effective, legitimate, asset-based and human centred, whilst acknowledging the need for joy and creativity to sustain community resilience.



ELEMENTS OF THE MODEL

- Strong local authority support for action on climate, nature and social – with a commitment to coproduction.
- Enabling local environment where the council and politicians; climate and nature organisations and businesses are part of an ecosystem in a local place which supports community led climate action to thrive.
- Collective of diverse and insightful community organisations and community leaders, from geographic and demographic communities as well as communities of interest.
- Independent coordination by a trusted, local, place-based organisation who collaborates both with local authority and with communities.
- Embedded carbon and biodiversity monitoring and climate communications expertise.
- Support from across the wider climate, nature and finance sectors.
- Funding, resourcing and understanding of the value of the contribution of the community sector.
- A commitment to an asset-based approach and just transition to a low carbon future.

THE MODEL INCLUDES...

CAPACITY BUILDING PROGRAMME for diverse local ‘non climate specialist’ community organisations to develop knowledge, confidence and resilience.

A CRITICAL MASS OF DIVERSE LOCAL COMMUNITY ORGANISATIONS coproducing strategic community-led climate and nature action plans with, by and for their community, through a process of community engagement and coproduction. Plans focus on both climate and social priorities as well as developing community leadership and agency on climate.

Through **WORKING WITH ARTISTS AND THE CREATIVE SECTOR**, the power of creativity is harnessed to engage more, and more diverse, people in the climate conversation in an accessible way at both the neighbourhood and city scale.

Representatives from communities who have plans and insights from stages one and two form a **COMMUNITY LEADERSHIP PANEL** to help strategically share insights, champion community priorities and influence local policy and decision-making on climate.

COLLECTIVE OF EMPOWERED AND INFORMED COMMUNITY ORGANISATIONS with community climate action plans work together to respond to a citywide priority to maximise agency and leverage, for example transport. This demonstrates strong community leadership in action on a key issue that impacts the majority of the local population.



DEVELOPMENT OF AN ‘ENABLING ENVIRONMENT’ in the city which champions community-led climate and nature action and has local council, climate and nature specialist organisations collaborating with the voluntary and community sector to create a connected and enabled ecosystem which catalyses change.

The model centres a just transition, supports both community and climate resilience and harnesses the social and community infrastructure which exists in all places. It also supports a cultural change in climate sector, local authority, voluntary and community organisations and citizens through positive collaboration, dialogue, and relationship building.
